

KEMPNER WATER SUPPLY CORPORATION DIRECTOR APPLICATION

All candidates shall meet the requirements set forth in Chapter 67 of the Texas Water Code, the Texas non-Profit Corporation action and the By-laws of KWSC. To be qualified for election or appointment as a director, a person must be:

- a. 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable; and
- b. a member of the corporation.

In addition to the qualifications listed above, a person is not qualified to serve as a director if the person:

- a. has been determined by a final judgment of a court exercising probate jurisdiction to be: totally mentally incapacitated; or partially mentally incapacitated without the right to vote; or
- b. has been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.

- a. candidate application number will be provided at the time application is received in corporation office;
- b. a petition signed by the lesser of 25 members or five percent of the members, requesting that the person's name be placed on the ballot as a candidate for that position;
- c. the person's written consent to serve, if elected;
- d. biographical information about the person; and
- e. a statement of the person's qualifications, including a statement that the person has the qualifications prescribed by Section 67.0051 of the Texas Water Code and Senate Bill No. 333

The application must be filed with the corporation not later than the 45th day before the date of the annual meeting.
APPLICATIONS ARE DUE BY 4 PM, FEBRUARY 8, 2016.
